THIS COLLECTION OF MATERIALS WAS LOANED TO THE PUBLIC ARCHIVES OF NOVA SCOTIA FOR MICROFILMING BY MICHAEL AND THOMAS LYNCH. (THE DONORS APPEAR ON THE NICHOLS FAMILY GENEALOGICAL NOTES AS 1e AND 5e. THE TWO COLLECTIONS WERE FILMED AS SEPARATE UNITS AND SO APPEAR ON THE FINDING AIDS.

THE MATERIAL IN THE TWO COLLECTIONS WILL TAKE THE RESERACHER FROM THE "MAYFLOWER" TO THE 1970'S. THE MAIN THRUST OF THE COLLECTION COVERS A GEOGRAPHIC BOX FROM SAINT JOHN TO DIGBY TO HALIFAX TO LIVERPOOL.
