Attempts at settlement in Acadia or Nova Scotia were made by the Portuguese about 1525 and by the French and the English early in the seventeenth century. The territory changed hands a number of times between the French and the English until 1713 when, by the Treaty of Utrecht, France ceded to Great Britain all Nova Scotia or Acadia "within its ancient boundaries," while retaining both Isle Royal and Isle St. Jean (Prince Edward Island). For several years governmental arrangements were somewhat makeshift. By 1719, however, British policy became more clearly defined and instructions more suited to the responsibilities of the governors of Nova Scotia were prepared.

Administrative functions for British colonies were given in 1696 to "The Lords Commissioners for promoting the trade of our Kingdom and for inspecting and improving our plantations in America and elsewhere." This body was also referred to as the Board of Trade and Plantations. By 1702, responsibility for the colonies had been assumed by the Secretary of State for the Southern Department. In 1768 the separate office of the Colonial Secretary was created. In 1782 the Board was abolished and colonial affairs were placed in the Home Secretary's Department. These were transferred to the Secretary of State for War and the Colonies in 1784, and a new Committee of Council for Trade and Plantations was established. Because of the war with France, the "Plantations Bureau" was not actually transferred until 1801. A separate Secretary of State for the Colonies was appointed in 1854.
