- June 17, 1786: Draft of Memorial of Commander Alexander Grant to the Commissioners appointed to enquire into the losses of those who suffered during the "unhappy dissensions" in America.
- **July 15, 1811**: Copy of letter, Alexander Grant to his brother Alpine, dealing with family matters. At seventy-seven years old, he relates his wife's recent death; writes of his children and grandchildren and his circumstance. He would die at his home at Grosse Point, above Detroit, in 1813.

- **1828**: Sentimental memoranda concerning the death of Isabella Gilkison.

September 5, 1828: French passport permitting W. Gilkison to go to Caen.

- January 17, 1829: Letter, W. Gilkison, Glasgow, to his son, Jasper, who with his brother Daniel is visiting their uncle, R. Gilkison, Pt. Glasgow. Sends instructions to them as to what they are to do. Mentions that Archy is traveling on the continent.
- **February 28, 1829**: Same to same. Gives him fatherly advice as to studies, conduct, etc.
- **April 4, 1829**: Letter, W. Gilkison, written from Dumfries, to his sons Jasper and Daniel, at school at Kilmarnook. Family affairs.

- August 18 September 1, 1829: Letters of introduction given Wm. Gilkison (6), during his visit to the United States.
- August 31, 1829: Codicil to the Will of Wm. Gilkison.

- March 27, 1830: Letter to W. Gilkison from Wm Richardson, Brantford. Talks about laying out of the town of Brantford; heard Fullerton has receipt from David but Wilson thinks the bill has been mislaid by David; further discusses David's

work competencies; Mr. L. and his private property in relation to creditors; new born Mary Dickson Racey?; Lovejoy mentioned in relation to Archy's pay per day.

"A Sea Boy..." written by W. as a teenager on board the ship "Mary" in 1793 – gives his impressions of captain and mates as news was heard of war.

Note concerns Nov. 1813 when he lost goods gotten from Gerrard & Co. when Americans seized them at Wm. Stewart's house; gives details of event.

Township of Nichol and how W. G. attained ownership of lands; also family history starting as sea captains – father William D and five sons sailing from Glasgow [good background information]; mentions relationship to John Galt, cousin.

Memoranda concerning Commodore Alexander Grant and his family.

Family history; experience in French and Indian War (Montgomery Highlanders) and American Revolution commanding vessels on the Great Lakes, home base at Detroit. [He was commander on Lake Ontario until 1778; commander of Upper Lakes thereafter.] Lists boats on the upper lakes, 1772-1793.

Letter book, 1777 to circa 1812 (sporadic in its dates).

"Early Days in Detroit" written by George Morin [adopted son of A. Grant].

William Richardson and militia at Brantford during the War of 1837.

Memoranda concerning McCormick (Thomas) Family, Queenston. [He was manager of the Bank of Upper Bank and son of Charles (Lt. in the Queens Rangers). Jasper T marries into this family line – married Mary Elizabeth in 1848.]

Plan for settling Elora, signed by W. Gilkison, 1838; additional note about David.

Memoranda concerning McKenzie (Thomas H.), Dundas. Genealogy Notes. [He was inspector of weights and measures, merchant in Preston 1832-40, employed with

Collin Ferrie general store as clerk and so was Jasper T. Gilkison.]

April 1, XXXX: Draft of letter requesting a meeting to arrange the completion of a canvass of the various city wards for subscriptions to stock in the Great Western Railroad Co.; draft of various resolutions concerning Great Western Railroad.
