#### 1 PROVENANCE

The years 1760-83, spanning the period from the end of the French and Indian War to the American Revolution, mark the apogee of British mapping in North America. By the mid-eighteenth century maps and plans at various scales were accepted as indispensable adjuncts both to the civil functions of colonial administration in an extensive Empire and to military needs for fortification, strategic planning and troop movement. Much of the original mapping surviving from these decades was thus commissioned by the Crown and carried out either by its officers or by appointees in its pay. The maps here reproduced provide a rich and representative sample of that cartography. From an historical point of view they are doubly significant: first, as map artefacts in their own right and exemplifying the development of cartography during the Enlightenment; and secondly, as original graphic documents forming a record, sometimes unique, of the events and places to which they relate. Furthermore, many of these maps, prepared in the public service and accompanying official correspondence or reports, are historically valuable not just for their content - as a series of topographical 'stills' of landscape - but as part of the wider processes by which official policies were decided or, in other cases, being integral to sets of documents in which political or military actions are recorded. In these respects the maps occurring in the Public Record Office are of primary interest among cartographic sources relating to eighteenth-century North America.

All the items on this microfilm are to be found in the map collection in the Public Record Office. They are listed in Peter A Penfold, ed. Maps and plans in the Public Record Office, 2 America and West Indies (HMSO, 1974) apart from addenda at the end of the film. (1) The full entries in that catalogue for each map have been reproduced as the description of the contents printed below. In relation to the Public Record Office collection of American maps as a whole the reels are selective in three respects:

- i) geographically they relate either to North America and the West Indies as a whole or to their internal political units and places within them. They thus range from maps of the whole continent down to sketches of quite small areas.
- ii) temporally they are all dated, sometimes as later versions versions of earlier maps, between 1760 and 1783, with the exception that later copies of manuscript maps relating to that period (usually made for official purposes) have been included (for example, MPG 67, 380 and MPH 581, 947).
- iii) they are confined to manuscript maps or to printed maps with significant manuscript additions. It was decided to exclude the many printed maps which occur in the Public Record Office relating to North America within the period on the grounds that they are available in general atlases or occur widely in major libraries. What constitutes 'a significant

manuscript addition' was a more difficult decision. Many of the printed maps in the PRO carry annotations, endorsements, or notes of some kind, if only of an identifying nature. A rule was therefore adopted to follow the official published catalogue; only printed maps where such additions are specifically noted in the descriptions have been reproduced.

Before their modern cataloguing the maps and plans originated in the records of a number of discrete government departments. For all maps this earlier provenance is revealed on the top line of the catalogue entries reproduced below. In terms of their association with these official classes of documents the maps are ranked as below:

From this list it appears - perhaps not surprisingly - that the principal government activity to generate maps of North America in the period was that of colonial administration. But in assigning provenance it also has to be recognised that many of these maps - and the records with which they were associated - were only so classified as a result of their reorganisation after American Independence. Thus many of the items in the Maps and Plans Class of the Colonial Office (CO 700) or in other CO classes appearing in the microfilms originated among documents of the office of the 'Lords of Trade and Plantations', a body which was abolished in 1782. (1) By the late-seventeenth century the Board of Trade (its usual abbreviation) was already associated with the systematic collection of maps of British overseas territories(2) but it was particularly active cartographically after the ending of the French and Indian War - even to the extent of organising the

growing collection of maps and plans and putting them under the care of a specially appointed draftsman.(1) Other maps received in this period were filed either with general correspondence (CO 5) or with records associated with particular administrative sub-districts or functions of government.(2) Many of the items filtering back to London were thus incidental to everyday administration in the colonies and were acquired through a variety of channels. At the same time the Board of Trade was also linked with ambitious ventures to survey systematically and compile general maps of the Northern and Southern Districts of North America: some of the original recensions of these regional maps, prepared by Samuel Holland or William Gerard de Brahm and their assistants, have found their way into the PRO and have now been reproduced for the first time.

The other important group of maps arising from the exercise of British control in various parts of North America and the West Indies were those prepared by the engineer draftsmen and surveyors of the Board of Ordnance. Maps of this provenance, in many cases executed by men who had received cartographic training either at the Drawing Room in the Tower of London or at the Royal Military Academy at Woolwich, are the nearest approach for the eighteenth century to an official style of British military cartography.(3) At the time of the abolition of the Board of Ordnance in 1854, the records passed to the War Office and many items were incorporated in a class devoted to maps (WO 78). In such ways the descent of the maps into their present PRO classes can be reconstructed, although the particular genealogy of individual items may have to be inferred entirely from the internal evidence of the actual maps rather than from external documentation. Of maps of this latter sort there are a considerable number, especially in the CO 700 and WO 78 classes.

From the above it will be seen that the maps reproduced here in no sense represent an organic collection. Rather they must be regarded as the total range - and often chance acquisitions - of maps coming to several government departments during the period. This self-evident truth is measured by the unusually diverse group of surveyors, draftsmen, copyists and other technical personnel who can be identified as making maps. Almost 140 individual cartographers were associated with the maps and plans included in this collection. That they number some of the most able and prolific practitioners of the Revolutionary era further points to the importance and representativeness of the collection. They include, for example, the young Captain James Cook (who learnt his surveying along the Newfoundland coast), Captain Thomas Hurd (future Hydrographer of the Navy), John Montresor (Chief British Engineer in North America), Samuel Holland and William Gerard de Brahm (respectively 'General Surveyors' of the Northern and Southern Districts of North America), military surveyors such as Lieutenant John Hills (whose manuscript atlas of New Jersey is in the Library of Congress) and Claude J Sauthier (private draftsman to Earl Percy) and Ordnance surveyors and draftsmen William Brasier and Charles Blaskowitz. Nor were map-makers always among the loyal British and names more famous in the American struggle for Independence - notably Thomas Hutchins and David Rittenhouse - are also found in the list of cartographers. The identification of the map-maker and the relationship of a specific map or plan to the work of that man in general is often a useful starting point in understanding many of these items.(1)

As with the map-makers, so too their maps and plans represent a wide spectrum of cartographic activity in eighteenth-century North America. Cartography as a distinctive means of communication is infinitely adaptable; there are thus almost as many types of map as there are functions they exercised. These maps and plans document and illustrate, inter alia, general small-scale topographical mapping of large areas; route and river maps; the depiction of inter-colonial and Indian boundary lines (together with 'purchases' of Indian land); sketches of explorations traversing the frontier; large-scale cadastral platting of land grants and layouts for new settlement sites; surveys of Loyalist estates; town plans; marine coastal charts and detailed harbour plans; and a whole suite of military maps used in reconnaissance and fortification or employed to record the movement of troops, battle engagements or defensive sieges in the Revolution. In addition the maps carry numerous accompanying notes and annotations of an explanatory or descriptive nature including references to population, the quality of land, timber resources, fishing, trade, navigation and the Indians.

Such maps, moreover, varied not only according to their intended or actual uses but with the nationality, training and skills of those who made them, the techniques they employed in the field and drawing office, the instruments and materials available (frequently they were makeshift in eighteenth-century North America) and the circumstances under which they were completed. Maps and plans can thus vary considerably in their conventional planimetric or topographical

'accuracy' and in appearance and style they stretch from highly coloured 'finished' maps, designed for presentation, to the roughest sketches laid down in the heat of the moment. In approaching such 'official' maps it is a sound principle to remember that it was their historical context as much as their apparent content which may determine any assessment of their contemporary 'relevance' or significance.

If any general principles are to be laid down for the historical interpretation of these early maps(1), it is that each one may have to be assessed as a separate historical document or at best grouped with very few others into small cartographic 'families'. Yet even as manuscript maps, the caveat should be entered that they cannot invariably be regarded as 'unique' items. A common practice in eighteenth-century cartography was the hand copying or 'duplication' of manuscript maps, especially for official purposes. Accordingly a number of the maps also occur - in almost identical recensions - in other collections including those of the British Library, the Library of Congress and the William L Clements Library. It may be concluded that any of these factors - depending on the historical problem under investigation - may be relevant to the interpretation of the maps as historical documents. For a satisfactory evaluation it is usually helpful to know something of the techniques of contemporary cartography as well as of the exact circumstances in which particular maps occurred.

#### 3 CONTENTS OF THE FILM

As already noted, the maps and plans reproduced here are catalogued in Peter A Penfold, ed. Maps and plans in the Public Record Office. 2 America and West Indies (HMSO, 1974). They have been filmed in the geographical order in which they are printed in that volume.

#### REEL 1

CO 700 America North and South No. 26 - CO 700 Canada No. 18 Includes general maps of North America and Canada including British Columbia, New Brunswick, Newfoundland, Nova Scotia, Ontario, Prince Edward Island and Quebec Province.

#### REEL 2

CO 700 Canada No. 28 - MPD 1 Includes a map of the St Lawrence River - Quebec Province, general maps of the United States of America and maps of Alabama, Alaska, Connecticut and Florida.

#### REEL 3

MPG 347 - MPG 597 (3) Includes maps of the United States of America including Florida, Georgia, Kentucky, Louisiana, Maine, Massachusetts, Michigan, Mississippi, New Hampshire, New Jersey and New York.

## REEL 4

MPG 22 - MPG 97
Addenda of items not listed in the catalogue.
Includes maps of the United States of America including New York, North and South Carolina, Pennsylvania and Vermont; maps of the West Indies and Bermuda including Antigua, Bahamas, Cuba, Dominica, Grenada, Dominican Republic, Jamaica, Martinique, Puerto Rico, St Vincent and Tobago; and addenda: maps of New Brunswick, Nova Scotia, Quebec and Vermont.

#### Note:

i) In the descriptions of individual maps it may be assumed that they were drawn or printed on paper unless some other material is specified. Measurements were made first horizontally and then vertically in feet, inches and tenths of inches. Scales are given when they appear on the map or have been deduced from other measurements. Where present, compass indicators or roses are noted. Reference to cardinal

points implies that the four main points of the compass, or one or more of them, are shown on the map, usually near its borders. The word 'coloured' in a description means that some colour appears on the map; this can range from a single, coloured boundary line to elaborate decoration.

ii) In the case of large maps photographed on more than one frame, an appropriate comment has been added to the original Public Record Office catalogue entry, eg FO 925/1650 (2).

For the complete exploration of the maps and plans on this film and in their relationship to printed cartography in the same collections, the official catalogue, Peter A Penfold, ed. <u>Maps and plans in the Public</u> Record Office, 2 America and West Indies (HMSO, 1974), is indispensable and supercedes the Catalogue of the maps, plans and charts in the library of the Colonial Office (Public Record Office, 1910). The general background to the cartography of the area and period is most adequately dealt with in William P Cumming, British maps of colonial America (Chicago, Ill: University of Chicago Press, 1974) which is accompanied by a full bibliographical essay. The same author's The Southeast in early maps (Chapel Hill, NC: University of North Carolina Press, 1958) is an annotated check list of manuscript and printed maps of the region in the colonial period but there are no comparable works for the rest of North America or the West Indies. On the often dominant theme of military cartography, John Brian Harley, Barbara Bartz Petchenik and Lawrence W Towner, Mapping the American Revolutionary War (Chicago, Ill: University of Chicago Press, 1978) offer a classification of military maps together with a discussion of their significance during the American Revolution.

Of the major collections where related and 'duplicate' maps are preserved, three are especially important: i) the British Library, described in Catalogue of the manuscript maps, charts and plans, and of the topographical drawings in the British Museum (3 vols., British Museum, 1844-61) but now supplemented by important additions to the holdings of both the Department of Manuscripts and Map Library, notably through the purchase of the collection of the Royal United Services Institution in 1968; ii) the Library of Congress, recorded in Philip Lee Phillips, A list of maps of America in the Library of Congress preceded by a list of works relating to cartography (Washington DC: Government Printing Office, 1901) and A list of geographical atlases in the Library of Congress (Washington, DC: Government Printing Office) vols. 1-4 compiled by Philip L Phillips, 1909-20, and vols. 5-7 compiled by Clara E. Le Gear, 1958-75; and iii) the William L Clements Library, catalogued in Guide to the manuscript maps in the William L Clements Library (Ann Arbor, Mich: University of Michigan, 1959), compiled by Christian Brun. But if these repositories are particularly rich in items similar to those reproduced from the Public Record Office, they by no means exhaust the dispersion of colonial items in the collections of the British Isles and North America. There is no union list of such maps but Cumming, British maps, provides the easiest initial route to the location of other caches of American manuscript maps made by British cartographers in the period.

Apart from the studies which have been footnoted above, there is a large periodical and monographic literature attached to some of the maps. Among recent essays, Louis de Vorsey, Jr., ed. de Brahm's Report of the General Survey in the Southern District of North America (Columbia, SC: University of South Carolina Press, 1971) and Don W Thomson, Men and meridians: the history of surveying and mapping in Canada, volume 1 Prior to 1867 (Ottawa: R Duhamel, Queen's Printer, 1966) can serve to

illustrate the potential richness of related archival material which can be used to set the context of some of the mapping. Finally, the annual bibliographies in <a href="Imago Mundi: the journal of the International Society for the History of Cartography"> Imago Mundi: the journal of the International Society for the History of Cartography are a regular source of additional references in a relatively well-documented period of early American cartography.</a>
