#### INTRODUCTION

The Ordinance of 1777 directed that in each of the Districts a Court of General Quarter Sessions of the Peace should be held "to hear and determine all matters relative to the Peace and whatever is by them cognizable according to the Laws of England."

Until 1841 the Courts of General Quarter Sessions of the Peace performed a double function, judicial and administrative, for the District. But at that time the municipal function was taken over by the district, and later the county, councils and the court retained only its judicial function.

At Confederation there was one such court in every county with the County Judge as chairman and, in practice, as the court itself. This court tried inferior crimes with a jury, with the possibility of an appeal to the County Judge. In 1868 the time-honored word "Quarter" was dropped and the court became the General Sessions of the Peace. By the Act 36 Vic., Chapter 8 of 1872, the County Judge's Criminal Court was set up for trials held out of sessions without a jury and from this time minutes for both courts appear.

Home District at various times included more than present day York County. The creation of Niagara District in the late 18th century and of Gore District in 1816 removed parts of the areas governed from Toronto (them York). Later separations included Simcoe County in 1837, Ontario County in 1854 and Peel County in 1867.

Home District minutes of proceedings from 1800 to 1811 have been printed and indexed in the Ontario Archives Report for 1932.
