Audit Office 3 consists of 1,430 bundles or volumes, etc. divided into numerous alphabetically arranged categories and subcategories. The material included is almost all prior to 1867 and relates, for the most part, to rolls preserved in A.O. 1, Declared Accounts. It contains particulars of the accounts, vouchers, and other relevant papers which often provide considerably more detailed information on the various items of expenditure. The transcripts and photostats are also available on 16 mm microfilm (reel C-2971).

Only a few selections from four of the categories have so far been copied. These are:

Bundle 120, "Divers accounts and vouchers, Canada", 1711-1822. Photostats, 1766, 1774-1789. 66 pages.

Eight items have been selected from the period 1766-1789. They include a number of military accounts, amonf which are one of James Murray, 1766, as Governor of Quebec, and 15 warrants of Frederick Haldimand, 1781-1784, while Commander-in-Chief at Quebec. There are also accounts of Sir Thomas Mills, Receiver General of Quebec, and of his Deputy, William Grant, 1778-1789. Further material on the case of the King v. Mills and Grant, deriving from a number of other Audit Office and Treasury classes, listed in Finding Aid 250, may be found in MG 55/14 2.

Volume 140, "Colonies and Dependencies. America, North. Papers relating to accounts of the survey". Transcripts, 1764-1808. 117 pages.

This volume contains papers relating to Samuel Holland's survey of North America, 1763-1808. The material has been indexed in the Public Archives of Canada General Index. A number of items connected with the victualling of troops in Upper Canada in 1795 is surprisingly included with the Samuel Holland Papers. Volume 141, which contains the account books of the survey, 1764-1783, has not been copied.

Three small items have been selected, all belonging to the year 1760, and concerned with medical supplies for troops in North America.

Finding Aid No. 90 contains the shelf list of Audit Office material on microfilm at the Public Archives of Canada. Finding Aid No. 250 provides a list of contents for all items which have been copied by the Public Archives of Canada and some information derived from the Map Division relating to the material in volume 140. Of the published aids mentioned in the MG 14 Introduction, those applicable to this class are the Guide to the Contents of the Public Record Office, II; Lists of the Records of The Treasury, The Paymaster General's Office, The Exchequer and Audit Department and the Board of Trade, to 1837, preserved in the Public Record Office; Guide to the Materials for American History, to 1783, in the Public Record Office of Great Britain, II, by Charles M. Andrews; and Guide to the Materials in London Archives for the History of the United States since 1783 by C.O. Paullin and F.L. Paxson. Andrews supplies the cross references to the corresponding bundles and rolls in A.O. 1, Declared Accounts, but does not refer to either A.O. 1 or A.O: 3 by class number, only by name. Paullin and Paxson list the bundle and roll numbers under the former class number, which was A.O. 2.
