 - Mentions Porteous' departure; expresses "all is for the best" post-Revolution and gives examples of positive affects for Porteous
 - Mentions Sampson's children ill with ague; James Seagence's? situation, treatment of Americans at Havana infamous, fearful property will be withheld
 - Requests oil cloths and a carpet; offered Indian goods at cost, feels optimistic about business
- Letter to Porteous from William Constable, NY, 5 Nov. 1784 (104)
 - o Mentions his wants for his brother
 - Government decisions concerning back rents and the effect of paper money "jig is up with the trade here"
 - \circ $\,$ Mentions Fleming and his financial troubles and love of money $\,$
- Letter to Porteous from William Constable, NY, 29 Nov. 1784 (105)
 - Mentions Porteous' setting out for Scotland
 - Informs the affairs of JS ruinous and is concerned it will affect him financially, JS at Philadelphia to sort out, mentions among other things, if vessels and goods at Philadelphia had not fallen so much by peace taking place, he would have had enough to pay off P & E
 - Mentions state of affairs at Havana has not helped his finances; updates on family and circumstances briefly – Sampson lost daughter and was not happy with the exchange in his money when settling his debts with Richardson; nanny's well and "all I have left"
 - Includes list of commodities and prices
- Letter to Porteous from William Constable, NY, 5 Jan. 1785 (106)
 - Concerning imports, prices and sales + summary: "sales are very dull"
 - \circ $\;$ Possible financial benefits of Congress moving to NY- increase house rents
 - Includes lists of commodities
- Letter to Porteous from William Constable, NY, 3 June 1785 (107)
 - Mentions John Richardson and his efforts concerning Augustine Adventure, and his dissatisfaction with the world

- Tries to dissuade Porteous from moving to southern climate as bad for health, and instead go to Nova Scotia; NS as pamphlets indicate, good business move for trade, Fleming may be interested as well, or another option could be if the posts are given up and P & E fix a House here, they may establish you here; hopes P & E don't establish a House at Halifax
- Account Col. Stephen Delancey with George Sutherland, 6 Feb. 1784 29 Apr. 1785; includes list of items and costs (108)

 - To P & E, NY, 6 May 1786
 - Sorry for distress caused you concerning my financial matters, explains further
 - Motives for building house at St. John; assistance of A.E. with his venture into fishery, hopes to succeed and compensate; issue with Col. & Co.
 - To My Dear Friend, NY, 3 June 1786
 - Concerning his situation at Nova Scotia and New Brunswick: started herring fishery at St. John and Bear River with GS for this season; mentions hardships and Mr. E's assistance and lack of certainty for next year; comments about doing business in St. John and trade from there; can't sell any of his good here except silver
 - Off tomorrow a.m. on sloop "Peggy," Capt. Elliot, chartered and loaded with salt
 - To Misters P & E, NY, 3 June 1786
 - Mentions Mrs. Constable has agreed to part with her boy Dick to Mr. Robert Ellice and hopes he'll allow her £100, explains what to do with money
 - Balance due by W.C. to be remitted from Canada, further explains and gives assurance of his payment in future – his House is thriving in this city
 - Groome is in jail
 - o To Dr. Colvill, 3 June 1786
 - Encloses bill of lading in the "Ranger;" has salt, flour and bread only in the "Peggy"
 - To Misters A. McGill & Co., St. John, 23 June 1786
 - Just arrived with cargo of salt from NY, want of cash, took liberty to draw on you in favour of Misters J. Colvill & Co.
 - Fishery in Bear River succeeds but being away is not advantageous for its success
 - To Misters Brymer & Belcher; requests acceptance of bill transmitted, if overdrawn, will pay
 - To Mr. Ritchie, Kincardin, 4 July 1786; urges payment as he's pressed by his obligations in NY
 - To John Robertson, Annapolis, 5 July 1786; vessel can't carry load of salt in his casks, etc.; delivery of flour for Mr. Ritchie, to send

- To [?], KIncardin, 5 July 1786
 - Loading sloop, would have loaded more except not purged enough of oil; confusion about price to charge recipient, low price not sustainableuncommon pains in pickling and extracting the oil, plus many disadvantages laboured under in first outset in the business
 - Has drawn on recipient in favour of Misters J.C. & Co.
- To A. Macomb, 29 June from Annapolis; our proposal etc. for the fishery was not so forward as I expected; explains the trials and tribulations thus far
- To J. Colvill, 29th [?] 1786; off to Digby tomorrow, mentions Capt. Park in discussion of supplies; herring fishery update: want of proper and timely preparations has prevented our having more ready for any market
- To Misters C.R. & Co., Digby, 30 June 1786
 - Been at Annapolis in hopes of getting some money, unsuccessful
 - Sent by the "Sally" our cured fish
 - Lists items, whether cleared or not, and where landed- St. John and P E I?
- To Mr. Colvill; business matter concerning Mr. Ritchie, needs it dealt with; look for directions on next ship from NY from W.C.
- To Capt. J. Park of the snow "Lively," Digby, 1 July 1786; discussing his fish businesscured and ready for market, waiting on his determination about boards, etc. in order to accept order, Rutherford & Nash mentioned; wrote note to Mr. Brown at Digby enclosing above
- To [?] Pope, St. John, 30 July 1786
 - Considerations to consider before starting business here: discusses specific goods that are sellable, with explanations; consumption of goods here very good, payments with precautions are not bad, and expects goods will be in great demand here before middle of Nov.
 - Carrying on herring business with George Sutherland higher up river than ours, for reasons already stated will only be able to cover expenses; business future uncertain
 - Impressions on Annapolis; list of items added at end of note
- To [?], KIncardin, 5 July 1786
 - Received your obliging favour and now send you tar and turp? from Mr. Sutherland
 - Sending all our fish; order for Capt. James Park- miscommunication in price to, hold money from in your hands; requests molasses be sent
 - Update on fish activity
- o To John Robertson, Kincardin; apologises for mistake in order of salt
- To C.R. & Co., 21 Aug 1786; list of items herein, if sent, he would sell; Colbourne is the best hand to manage all these matters; requests rags of newspapers
- o To Rutherford & Nash, 22 Aug 1786 (from Annapolis); concerning herring delivery
- To C.R. & Co. from Bear River, 21 Aug. 1786

- Concerning order recently sent: flour prices rising so didn't send whole order; twine and price of high, pork not good- not inspected properly suggests, not sure if pork left at St. John is ok
- Hasn't sent bills as it is necessary for him to stay close to his business, fishing is unsuccessful
- To Dr. C.?; suggests he does something about his account as it makes Porteous appear negligent; remarks his situation has become disagreeable and almost insupportable
- Dear C. from Bear River 17 Nov. 1786; encloses bond; requests money in sterling; sorry for recipient's situation
- To Misters C.R. & Co. from Bear River, 17 Nov. 1780
 - Mentions he has been up St. John River; unsuccessful in getting any remittances for you as at present country is exceedingly bad to collect debts in
- To M.G. from Bear River, 10 Aug. 1786; requests helping his friend G.S., a stranger in Halifax with money, advice and introducing him to serviceable people; G.S. helping to manage Porteous' affairs
- To A. Brymner; requesting his assistance to G.S. concerning land
- o To Dr. C.? from St. John, 2 Aug. 1786
 - Concerning account of James McLean
 - Requests 2 anchors addressed to Misters C. & Co. for schooner they are now building
 - On his way over the Bay having been here and up the river these 2 weeks; good crops expected this year but want of provisions unless government allows them more; capable of raising their own flour on a good year; want of pork
- Letter to Porteous from Wm. Constable, New York, 13 June 1787; James Ellice is in town; apprehension that Porteous' boats are liable to seizure, but "as none of them are new I cannot suppose your collector can consider then as merchandise" (110)
