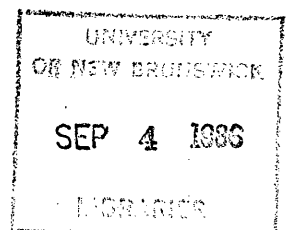

PREFACE

This Reel Guide and Subject / Name Index accompanies Research Publications' micropublication of The New York Historical Society's collection of Early American Orderly Books. Written in manuscript, the books are a unique and valuable resource dating from the French and Indian Wars through the War of 1812. While orderly books from both British and American armies have been included, the bulk of the collection consists of American orderly books kept during the Revolutionary War.

On the microfilm, the orderly books are arranged chronologically by the date of the first recorded entry. A target containing the collection number and descriptive information precedes each title. For greater user convenience, each microfilm reel also begins and ends with an eye-legible target identifying the books contained on each reel by collection number.

The Reel Guide follows the chronological organization found on the microfilm. For each title, the collection number and reel number are provided to the left of a short description, identifying the book by outfit, colony/state, dates of coverage, commanding officer, author(s), and battles or operations. Wherever possible, additional information has been included in the description, but in some cases, even identification by regiment or commanding officer has not been possible.

The Subject / Name Index is included to provide the reader with quick access to the collection by unit, location, commanding officer, author(s), and battle or operation. The collection numbers of relevant titles are located to the right of each entry in the index. To locate the proper microfilm reel, one would use the collection numbers to refer back to the reel guide where the pertinent reel numbers are listed.

Some facets of the indexing require explanation. Because regiments were commonly identified by the name of the commanding officer and by the colony or state of origin, they can be retrieved in the index under either designation. Frequent reorganization of American Revolutionary units has also made it necessary to distinguish the regiments of some states by date. For example, the 1st Connecticut Regiment of 1777 was an entirely different unit from the 1st Connecticut Regiment of 1781. Also, where place names are known to have changed and where personal names might be confusing, a 'See' reference has been provided so that the reader can identify pertinent orderly books under either name.

In identifying specific units and commanding officers, two books were especially useful. They are Mark Boatner's *Encyclopedia of the American Revolution*, New York, 1966, and Fred Anderson Berg's *Encyclopedia of Continental Army Units...*, Harrisburg, 1972.

Research Publications also wishes to thank the staff of the New York Historical Society for its cooperation and valuable assistance.
