- 14. 19 June 1780. Letter from Thoma's Brown. He is an unfortunate situation and has been greatly deceived. Calls Mr. 8. (presumbly Eraffoa) "as greatly hypocrite, republican and viloin as any in New Scotland". He was much pleased with Bailey's narration, copied it and sent it off for publication. Discusses events in Boston. He is very sorry to find push and abuses have attended Bailey since the troops left Cornwallis. War news. Mr. Weeks has intimated his attention to persuade Bailey to take a tour of Annapolis with him.
- 15: 17 July 1780. Letter from J./Weeks. There has been a sad combustion on Bailey's account- tho of St. Patrick all united against Bailey.
- 16. 18 July 1780. Letter from Joseph Bass. He is glad to hear that Bailey is delivered from the hands of unreasonble men.

 Should Bailey come his way (Annapolis) he is welcome to visit.

- 17-18. 7 August 1780. Letter from the Reverend Samuel Peters. He returns a poem (no. 18). The remainder of the letter is taken up with remarks on religion and politics.
- 19. 12 August 1780. Note from Antill Gallop. Invites Bailey and family to Windsor, no small pox there.
- 20. 15 August 1780. Letter from Henry B. Brown. Wants to know why Bailey has not visited him in Halifax- no danger of small pox- discusses a literary composition of Bailey's- no longer any fear of invasion by French- so tall the "brave and loyal Militia" of the Province.
- 21. 17 August 1780. Letter from Joseph Sornett. He writes from London and thanks Bailey for his anxious concern on his delivering from his cruel persecutions in New York.

- 51. 29 January 1782. Letter Withain Morrise, London. J. Weeks has refused the Annapolis mission and Bailey appointed. He is reside there and receive 50 and another 70 from the government. The chaplain ry of the garrison should be given to him. Refers to the disloyal conduct of the Bass.
