Series 6: Judgments

Series 6: Judgments. - 1788-1969. - 8 meters, 70 cm.

This series consists of judgment books and their indices. Judgment books contain the decisions of civil proceedings in the Supreme Court listing the names of the parties involved and the debt owing to the creditor (plaintiff). If the debt has been satisfied this is indicated within the index and the judgment book entries. Most judgment books appear to contain judgments for civil cases in all three counties with the majority being Queen's County cases. This series sub-divides into two sub-series; Judgment books and Indices to judgment books.

SUB-SERIES DESCRIPTIONS FOLLOW

Judgment minute books 1965-present and an index to the judgment minute books are held at the Sir Louis Henry Davies Courthouse.

Accruals expected.

Subseries 1 Judgment books. - 1788-1910. - 7 meters, 70 cm.

This subseries consists of 49 volumes of judgment books. The books contain page long forms which list the decision of civil proceedings in the Supreme Court. Each page contains the judgment for one cause and lists the names of the parties and debt owing to the creditor. If the debt has been satisfied this is noted in the margin of the form. The judgment is signed and dated by the prothonotary of the court thus registering the judgment. The surname of the plaintiff's attorney is also included. The volumes are numbered 1 to 50 and arranged in the original numerical order. **Volume 2, 1796-1801, and Volume 51, 1910- are missing.** The judgment books are indexed in the indices of Subseries 2: Indices to the judgment books.

Volumes 23-50 are oversize.

Subseries 2 Indices to judgment books. - 1789-1969. - 1 meter.

This subseries consists of 8 bound volumes. The indices contain one line entries per cause which are arranged (roughly) alphabetically by the debtor's surname and by year. The entries consist of the defendant's and plaintiff's names, page and judgment volume number references, the date, the amount of the debt, and the word "satisfied" and a date if the debt has been paid. The indices are arranged chronologically. There are no corresponding judgment books for entries after 1910 since Volume 51 which is referred to in Volume 8 of the indices is missing.

VOLUME LISTING FOLLOWS.

Volume 8, 1898-1969 contains few entries for the time period 1930-1969. Original numbering is indicated in square brackets.

The indices are oversize and shelved in the stacks preceding the judgment books of Subseries 1.
