- North Pier is dangerous; recommends that it be closed up and that a new one be erected.

- The Jury suggests that officers should be sent out to determine who is selling liquor without a licence.
- A wall in the road in Portland Parish is dangerous and a public nuisance and should be removed.
- The state of chimneys of a house on Prince William Street is a public nuisance and should be fixed for safety reasons.

- The alley by this house is in a filthy and dangerous state.
- The South Market Wharf requires repair.
- Public Wells in Market Square and King Square need repair.
