They regret that the same remarks cannot be applied to Duke's Ward
- In some streets in Duke's Ward, the gutters are full of filth and the stench arising from the putrid
  matter is almost insufferable. They beg to suggest that the present Road Master in that Ward is
  very unfit for the duties of the office.
- The Grand Jury find the Gaol very insecure particularly the upper part of it and they recommend such improvements made for its security as the Sheriff may point out.
- A barn and fence belonging to Mr. Andrew Hutchinson are at least three feet on the Street and the Privy from the yard flows into the street occasioning such an offensive smell.
- A house at the upper end of Duke's Street belonging to John Henderson and occupied by one Mr. Andie projects into the street upward of six feet.

- A flight of steps is encroaching on Dock Street.

- The Assessors of Taxes and Collectors are to be assessed based on percentages given.

- Overseers of the Poor for the eastern part of the City of Saint John are not to give relief to
  persons out of the Poor House between the first day of May and the first day of November
  following unless there is an urgent cause.
- The physician for the Poor House is to also attend to persons in the jail when there is need and he shall be required by the High Sheriff to do so.
- It is recommended that the Overseers of the Poor shall adopt the like system of feeding the poor as is adopted in the Marine Hospital in the City. If this happens, Mr. Heaviside and Mr. Donaldson will assist the overseers in arranging and keeping the necessary accounts.
- Mr. Betts is to be paid by the Collector of Taxes for repairs to the Poor House.
- Upon reading the petition of William Jarvis, John Kerr and Alexander McLeod, it is orderd that the Collector of Taxes pay them for assessing the city rates.
- Persons residing between the Mill Bridge and Indian House who are granted tavern licences are to be fined a sum.
- Those with licences at the Indian house are to be fined a sum and are to be limited to the number of seven.

# **Court Orders**

- Ordered that a new warrant issue for a sum that was to be assessed on the Parish of Lancaster but was not.
- Ordered that the Clerk transmit the school certificates to obtain provincial allowance.

 Orrdered that the sum assessed by Assessors of Taxes for City of Saint John be paid by the Collector.

**Grand Jury Presentments** 

- Read the report of the committee to superintend the building of the new Court House:
  - They have prepared a bill to enable the sessions to borrow money for the construction of Court House and to pay off the same by annual assessment.
    - Sums included
  - They have also prepared a petition to the Legislature for the passing of the bill into a law
  - o They hope for financial aid from public.
  - o The committee has not yet determined the best plan for completing the Court Room
  - Mr. Cunningham has prepared a plan for an expensive portico for the front of the building. They decide to complete the interior of building first.
  - o The original stair plan would interfere with the portico.
  - The committee attaches the contractor's account for the erection of the Court House made up from County Treasurer and Collector's accounts:
    - Includes first and second assessments and the net produce of the assessments
  - Committee says that the contracts of Mr. Cunningham were all completed on time except for that for the front steps as a portico was in contemplation.
  - The committee had to borrow money from H. Johnston Esquire to pay the contractor.
     They are also hoping for money due from several Parishes and from the County
     Treasurer.
  - $\circ\quad$  The remainder of the City Grant will go toward finishing the interior.
  - The County Treasurer is overcharging for commission. His charges are irregular and go against an act of Assembly.
  - The committee has only received a portion of the amount assessed by the City and County—including the sum paid for jail wall balance.
  - The Collector of Taxes for the City and Portland has collected a sum from city and Portland delinquents. He reports that constables in Portland have also collected monies but have not given them to him.
- The recommendations of the said committee are to be adopted.
- Read a petition by the Justices of the Peace of the sessions requesting that the Legislature provide financial aid for completing the Court House:
  - o They have proceeded in erecting the new Court House.
    - Exterior cost £5000
  - $\circ\quad$  The city has suffered many losses due to the universal depression.
  - The above economic suffering is affecting the City of Saint John and the Parish of Portland for the support of transient poor.
    - Hoped that the legislature would have relieved them
  - They trust that their erection of the new Court House is validated by its convenience and its exterior beauty.
    - They knew that it would be costly
  - $\circ$   $\;$  Funds are still required to repay sums due for the exterior of Court House and for the completion of the interior.
  - They wish to borrow £4000 and to pay it off by annual installments of £400 and they have prepared a Bill to have passed into a law.

- o They hope his Excellency and Honors will be pleased to grand this sum.
- Read the draft of the Bill to authorize the Justices of the Peace of the City and County of Saint John to raise the sum of money for completing the new Court House.
- Read a bill relative to the streets and squares in the City of Saint John.
- Read certificates from the Trustees of Schools:
  - The Trustees of Schools in Carleton certify that in Guy's Ward a public school house has been built as requested by the act of Assembly
    - Teachers mentioned: John Howe; Robert Salter
    - A sum has been paid by the inhabitants of the ward for the support of the school
  - o A public school has also been built in Brook's Ward as required
    - Teachers mentioned: Robert Salter; Ida Mosher
    - A sum has been paid by the inhabitants of the ward for the support of the school
  - o A school house has also been build at Manawagonish (district of Parish of Lancaster)
    - A teacher mentioned: James McLaughlin
    - The school has been regularly kept for a year
    - A sum has been paid by the inhabitants of the district for the school
  - o A school house has been built at Musquash district in Lancaster Parish
    - Teacher mentioned: Robert Robertson
    - The school has been regularly kept for a year
    - A sum has been paid by the inhabitants of the district for the use of school
